Mooring Policy

The San Luis Yacht Club (SLYC) has one mooring available for *vessels up to 56 feet*. The mooring is located west of the Avila Pier. Mooring information is available on the SLYC website: slyc.org/moorings. Port San Luis Guest Services and Mooring information is available at: portsanluis.com/2159/Mooring-and-Boating-Services.

MOORING RENTAL FORM:

A completed and approved [Mooring Rental Agreement Form](#) is required for any vessel using a SLYC mooring. Download and complete the [form](#). Once completed, email or text the form to the Port Captain. If approved, the Port Captain will email an approved copy of the form to the requestor. Use of the mooring is subject to the SLYC mooring policies as detailed below:

LIMITATION OF MOORING CAPABILITIES:

The SLYC mooring season and mooring capability is determined by the Port San Luis Harbor District. The SLYC mooring is capable of securing yachts **up** to 56 feet.

ASSIGNMENT OF MOORING:

Guests:

The SLYC Mooring is available to vessels visiting Port San Luis, on a "first come – first serve" basis with preference to owners who make a reservation. The maximum stay is 15 days in a 30 day period.

Members:

The SLYC Mooring is available to vessels of members of the San Luis Yacht Club on a "first come – first serve basis" with a preference to Guests with confirmed reservations and then to SLYC members who make a reservation. The maximum stay is 5 consecutive days and must not exceed a total of 15 days in a 30 day period.

Mooring Fees:

Visiting members of reciprocal yacht clubs will be allowed to stay the first 24 hours free of charge. Thereafter, the daily rental fee is \$15.00 paid in advance to the SLYC. Delinquent payment may result in removal from the mooring.

LANDING:

Due to the closure of Avila Pier from structural damages - landing on the east side of the Avila Pier (the eastern most pier) is not available for loading and unloading crew and supplies. This includes the dinghy mooring line located on the west side of the pier. If you do not have a dinghy, a Port San Luis Water Taxi may be available. Contact the Water Taxi (805) 305-4796 or Harbor Office (805) 595-5400 for additional information.

The [SLYC Port Captain](#) handles disputes and is the ultimate authority in decisions regarding mooring assignments. All users agree to abide by the rules of the SLYC and Port San Luis Harbor District. The Port Captain and/or the Port San Luis Harbor Patrol has full authority to require any vessel be removed from the mooring if those responsible for the vessel act in a manner which creates a hazard, disturbs the peace, or act in a manner inconsistent with the bylaws of the San Luis Yacht Club.
